In connection with the previously announced cash dividend of \$0.25 per share of Theravance, Inc. (the "Company") paid on March 31, 2015 to stockholders of record as of the close of business on March 12, 2015, the conversion rate (the "Conversion Rate") with respect to the Company's unsecured convertible promissory notes due 2023 (the "2023 Notes") was adjusted. The Conversion Rate was adjusted from 48.3294 shares of the Company's common stock per \$1,000 principal amount of the 2023 Notes to 48.9758 shares of the Company's common stock per \$1,000 principal amount of the 2023 Notes, which represents an adjusted conversion price of approximately \$20.4182 per share.
